225/23 - STATEMENT OF FINANCIAL POSITION

The Director of Resources introduced a report setting out the financial position of the Charity as at the end of the 2022/23 financial year and provided estimates for 2023/24. The report also sought approval for the investment of the Charity's funds with Derbyshire Dales District Council.

In 2022/23, the charitable fund administered by the Council had earned on average an interest rate of 0.90% for 2022/23 earning £1,357. Grant payments in 2022/23 amounted to £3,980.

At the last meeting of the Committee in November 2022, the freehold sale of a section of the land at Pope Carr Road, Matlock was approved. After the costs of the surveys etc had been deducted, the net proceeds amounted to £17,192.50. The Director of Resources invested the net proceeds, adding them to the £150,00 investment, the endorsement of this decision was sought from Members.

The Charity's financial position at 31 March 2023 was £169,316.95.

For 2023/24, it was noted that the amount available in the distribution fund was £7,813, being equal to the estimated interest receivable in the year. Members were informed that, if they wished to do so, they could award grants totalling £7,812.52 plus up to £2,124.45 and still retain an investment of £167,192.50. Any grants awarded over the forecast would reduce the balance carried forward.

The recommendations as set out in the report were moved by Councillor Steve Wain, seconded by Councillor Susan Hobson with the removal of recommendation 4 and the addition of recommendation 5:

5. That payment of grants may not be made until documentary evidence of expenditure has been sought, except in exceptional circumstances where evidence cannot be provided until after expenditure has taken place.

The motion was then put to the vote and

RESOLVED (unanimously)

- 1. That the financial statement for the 2022/23 financial year be received.
- 2. That Members endorse the investment with Derbyshire Dales District Council in respect of the net proceeds of £17,192.50 from the sale of land at Pope Carr Road, Matlock.
- 3. That the funds of the Charity continue to be invested with Derbyshire Dales District Council.
- 4. That progress on the Review be noted.
- That payment of grants may not be made until documentary evidence of expenditure has been sought, except in exceptional circumstances where evidence cannot be provided until after expenditure has taken place.

Distribution of Charitable Funds

1. Background

The terms of reference for the Ernest Bailey Charity Committee are to ensure that funds are applied for the general benefit of the inhabitants of Matlock and district in one or more of the following ways:

- For the relief of the aged and poor
- For the relief of distress and sickness
- To provide or support facilities for recreation and other leisure time activities
- To provide or support educational facilities, or
- In such other ways as the Trustee thinks fit.

The area of benefit is the former area of the Matlock Urban District Council i.e. Matlock, Matlock Bath, Bonsall, Cromford, Darley Dale, Northwood and Tinkersley, Rowsley (part), South Darley, Starkholmes, and Tansley.

2. Key Issues Funding of Applications

2.1 Financial

The usual practice is to consider current grant applications from within the current year's interest receipts, estimated at £7,812.52 for 2023/24. The November committee awarded grants totalling £5,810, which leaves £2002.52 unspent. There is an additional £2,124.45 that can be awarded and still retain the £167,192.50 investment. If the Committee wishes to do so, it could award grants totalling £2002.52 plus up to £2,124.45, i.e. a total of £4,126.97 and still retain an investment of £167,192.50.

2.2 Applications

A total of 13 applications have been received which are summarised on the attached schedule in Appendix 1. Based on merit and the financial position of the applicants, there is £2002.52 left from the committee on 23rd November 2023. This can be increased up to £2,124.45 as stated above, to give a total of £4126.97.

2.3 Proof of Spend

At the last Committee, members discussed the need for applicants to prove the funds awarded were for the purposes stated in the application form. Members agreed that applicants should pay up front, unless there are exceptional circumstance, where they are unable to afford this. This would be the case for the individuals who are applying because of hardship but some of the groups couls have cash flow issues, with little or no reserves. It is proposed that we change this requirement, to providing evidence of the spend, such as invoices and receipts. After investigating what other grants schemes do, some ask for proof of spend or send out evaluation forms and rely on trust. It is very rare for grants to give retrospective funding.

7. Financial and Resource Implications

- 7.1 The Charity has £167,192.50 invested with Derbyshire Dales District Council and for 2023/24 interest earned is expected to be £7,812.52, at an average rate of 4.67%.
- 7.2 The following interest rates have been applied to the estimate for 2023/24:-
 - 4.19% from 1st April 2023 to 18th October 2023. 5.29% from 19th October 2023 to 31st March 2024.
- 7.3 The usual practice is to consider current grant applications from within the current year's interest receipts, estimated at £7,812.52 for 2023/24. The November committee awarded grants totalling £5,810, which leaves £2002.52 unspent. There is an additional £2,124.45 that can be awarded and still retain the £167,192.50 investment (comprising £150,000 capital receipt and £17,912.50 net proceeds from the sale of land at Pope Carr Road). Should the Committee decide to award grants totalling more than this level, the result would be a reduction in the amount available for distribution in the future. If the Committee wishes to do so, it could award grants totalling £2002.52 plus up to £2,124.45, i.e. a total of £4,126.97 and still retain an investment of £167,192.50.
- 7.4 The financial risk is assessed as low.

8. Legal Advice and Implications

- 8.1 The District Council became the sole Trustee of the Ernest Bailey Charity following approval by the Charity Commissioners on 12th April 1985. This function was later delegated to the Ernest Bailey Charity Committee.
- 8.2 Trustees have a legal duty to protect the charities assets and apply them for the charity's charitable purposes.
- 8.3 This report set out 2 recommended decisions to be taken. If decisions are made in line with the recommendations the legal risk has been assessed as low.
