Workshop Aims

To enable Councillor's understanding of the development of the Council's Corporate Plan 2024–28

- Information on the budget and likely future impacts



What is the Derbyshire Dales Plan 2024-28?

- It sets out the main priorities for the Derbyshire Dales district.
- It is the key strategy from which the District Council's Budget and Service Plans cascade
- It shows the key priorities for the District for four years (e.g. affordable housing, better jobs, tackle climate change)
- These priorities link to actions
- Progress on actions are reviewed and reported every year
- Reflects Member and Resident wishes but also grounded in actual need
- Acknowledges there is not enough resource (people or £) to do it all at once




Progressive Alliance Priorities

Financial Position


The following are likely to influence our future budgets:

"Building more affordable environmental sound homes for rent and buy." "Maintaining jobs in towns by supporting businesses"






Residents Workshops Results

What priorities and projects for clean, green and safe do you think should be in the next 4-year plan?

- More litter picking
- Keeping the parks and open spaces clean and tidy
- More projects related to climate change and biodiversity
- Maintaining an emphasis on recycling and an effective waste/bin collection service

"Climate crisis needs to take priority and be built into everything somehow." "Greater focus on biodiversity - e.g. establish more wildlife corridors" "Maintain a reliable bin collection system on days specified"






Residents Workshops Results

What **community priorities** and **projects** do you think should be in the next 4-year plan?

- Provision of public toilets was important to those present
- Support for reviewing car parking service and facilities
 - especially the costs of town centre car parking in Ashbourne.
- Support for leisure centres and facilities

"Public toilets – plea to reopen the public toilets in Ashbourne Park" "Cheaper car parking charges could be a way of attracting people into the town"

"Maintain quality and facilities for sport and recreation"





Focus Group Results

Both workshops suggested:

additional investment in support of the **local economy**, **housing** and measures relating to **climate change**

limited budget redistribution away from **central services** and **financial management**.

Key messages

Spending more on one thing means spending less on another

Any changes cost time and money to enact

We can't do everything immediately

Planning can start for longer term projects

Capital projects generally need external funding

Applying for and managing funding takes time, staff and money
